Detachment Executive Committee Meeting Des Moines, Iowa February 3, 2024

Commander James Lastovka opened the meeting in proper fashion at 9:00 AM. Detachment Chaplin Levi Frost offered the opening prayer and Detachment Parliamentarian Michael Deacon stated the rules of the meeting.

Richard Witt Fourth District gave his report and is on file. He noted that Rockwell #208 and Decorah #163 should be closed with Decorah sending a letter requesting to be closed.
